
Population

A region's economy thrives or dives because of the people who choose to live there. That choice may occur by being born there and desiring to stay, or a more deliberate one of choosing to relocate from somewhere else. Population Over Time











Commuting



Commuting Patterns: Top five counties sending workers INTO county, 2012


